Please be aware that the Royal Devon University Healthcare NHS Foundation Trust (Royal Devon) has existed since 1st April 2022 following the integration of the Northern Devon Healthcare NHS Trust (known as Northern Services) and the Royal Devon and Exeter NHS Foundation Trust (known as Eastern Services).

I am writing to make an open government request for all the information to which I am entitled under the FOI Act 2000.

Can you please provide an update on your Trust's Infrastructure? The six questions are in the attached spreadsheet, which I would be grateful if you could fill in.

Please note – question 6 – Annual spend 2022-23: The trust applies a refusal notice for this question under Section 17 of the Freedom of Information Act. As such the Trust applies the following exemption:

Section 12 (1) - Time/Cost (over 18hrs work)

The Trust has considered your request however, we are not able to respond to this question as it would involve a search by device it would be a time/cost manual search of individual record. To provide you with the information requested would require the manual extraction and manipulation of information from various sources.

To carry out this work would exceed the appropriate cost limit as set out in Section 12 (1) of the Freedom of Information Act 2000 and is therefore exempt.

Under the Freedom of Information Act 2000 Section 12 (1) and defined in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004, a public authority is not obliged to comply with a request for information if it estimates that the cost of complying would exceed the appropriate limit. The limit of £450 represents the estimated cost of one person spending two and a half days in determining whether the Trust holds the information, locating, retrieving, and extracting that information.
