Please be aware that the Royal Devon University Healthcare NHS Foundation Trust (Royal Devon) has existed since 1st April 2022 following the integration of the Northern Devon Healthcare NHS Trust (known as Northern Services) and the Royal Devon and Exeter NHS Foundation Trust (known as Eastern Services).

This is a request under the Freedom of Information act.

- 3. Please can you provide all the information, reports, and documentation, going back three years.*

Trust answer: All food hygiene inspections are available via the food standards agency website; our units all are recorded as 5's so no action plans required.
